Dr. Fedorczyk called the meeting to order at 10:02am.

**Review of Agenda and Minutes:**

The September 11, 2014 Agenda was reviewed by the Board. Dr. Frieman moved to approve the September 11, 2014 Agenda as written; Dr. Lewis seconded, and the motion was unanimously approved by the Board.

The August 14, 2014 Board Minutes were reviewed by the Board. Dr. Nou moved to accept the Board Minutes as written; Dr. Frieman seconded, and the motion was unanimously voted by the Board.

**Federation of Chiropractic Licensing Board District Meeting – Dr. Michael Fedorczyk**

Dr. Fedorczyk and Dr. Nou attended the FCLB District Meeting in West Palm Beach, FL. Some topics of discussion included the practice of veterinary adjustments, medical marijuana being utilized with chiropractic services, the expungement of records when a chiropractor has committed minor infractions and reinstatement of a chiropractor's license.

**Review of Administrative Issues, Mr. J. J. Vallone, JD, Executive Director and Ms. Adrienne Congo, MS, Deputy Director:**

**a) 2014-2016 Massage Therapy Biennial Renewal Update**

The Board has opened up the Online Renewal System for Massage Therapy renewals effective August 28, 2014 (late evening). Currently between Aug. 28<sup>th</sup> and September 11, 2014; 318 individuals have completed their renewals and 86 are in progress. Technical difficulties have

stemmed from the IT Department and Programmers changing all of the Boards online renewal application templates and changes with the Bank of America Cybersource connections which now require an email address on the payment page. We have made a Cybersource dummy email for those licensees who do not have an email address and the ability of those who do to change the dummy email to their current email. Resolutions to limit number of characters in CEU information fields have been increased from 25 characters to 100 characters. Renewal Application aesthetics was changed by Ms. Congo with cooperation of the MHCC Programmer to present a more aesthetically pleasing appearance and sequentially appropriate.

Mr. Cramer graduated with 700 hours from the Health-Choices Institute and Holistic Massage School in Hillsborough, NJ and successfully passed the MBLEX in 2014. The Health-Choices Institute and Holistic Massage School in Hillsborough, NJ is approved under the New Jersey Department of Education.

Based on this information, Dr. Chaney moved to approve Mr. Cramer's petition to continue with the application process for massage therapy licensure/registration; Dr. Frieman seconded, and the motion was unanimously voted by the Board.

Based on this information, Dr. Frieman moved to approve Ms. Turner's petition to continue with the application process for massage therapy licensure/registration; Ms. Harrison seconded, and the motion was unanimously voted by the Board.

**c) Dennis Ossiander, (Massage Applicant) – Petition to Waive Accreditation Requirement and Approval to continue Application Process for Massage Therapy.**


